# C: Primary charges from 1 April 2025

#### C1 Introduction

This section of the document sets our water and sewerage charges from 1 April 2025

Section references correspond to the relevant sections of the Scheme of Charges set out in section B. For example, unmeasured charges explained in section B2 relate to the unmeasured charges tables set out in section C3 below.

From 2023 onwards, the charges applied to your site on a deemed contract will be different depending on the total level of consumption you use as a customer. Where you have multiple sites, the consumption for each of these sites will be added together for the purposes of defining customer group. The 3 customer groups are defined by usage between 0–500 m³, 500–50,000m³ and usage greater than 50,000m³ respectively. An additional retail fee will be applied to sites, detailed in table 1.

These charges are also often used in our express contracts with you as our basis for charging.

#### C2 Measured charges

Measured charges for water are shown below. The volumetric element is charged per m<sup>3</sup> with a fixed charge also being applied to the water services charges based on the size of the water meter (see table 4), and an annual fixed charge per site (see tables 2 & 3).
